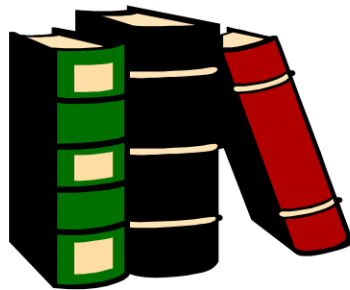

# **AMENDMENT TO THE RULES OF PROCEDURE OF THE HOUSE OF REPRESENTATIVES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA**

NOTE: The Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina was published in the “Official Gazette of Bosnia and Herzegovina”, 79/14.

Pursuant to Article IV.3.b) and d) of the Constitution of Bosnia and Herzegovina and Article 186 of the Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina (Official Gazette of BiH, 79/14, 81/15, 97/15, 78/19, 26/20, 53/22, 59/23, and 87/23), the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina, at its 20<sup>th</sup> session, held on 16 July 2024, enacted the following

## **AMENDMENT TO THE RULES OF PROCEDURE OF THE HOUSE OF REPRESENTATIVES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA**

### **Article 1**

In the Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina (Official Gazette of BiH, 79/14, 81/15, 97/15, 78/19, 26/20, 53/22, 59/23, and 87/23), in Article 61, paragraph (1), sub-paragraph f), after the words “reconstruction and”, the word “sustainable” shall be added, and after the word “Herzegovina” the punctuation mark semicolon shall be replaced with the punctuation mark comma followed by a new word that is added “including”.

Under sub-paragraph f), the following indents shall be added, which shall read as follows:

- 1) Implementation of documents contributing to the achievement of sustainable development and international obligations in the area of sustainable development in Bosnia and Herzegovina;
- 2) Planning the financing of development priorities defined in the strategic documents of Bosnia and Herzegovina, which contribute to the achievement of sustainable development in Bosnia and Herzegovina;
- 3) Relations with the authorities competent for monitoring the achievement of sustainable development in Bosnia and Herzegovina;
- 4) Alignment of strategic documents of Bosnia and Herzegovina with the documents contributing to the achievement of sustainable development in Bosnia and Herzegovina and analysing their implementation;
- 5) Implementation of documents pertaining to the achievement of sustainable development and international obligations in the area of sustainable development in Bosnia and Herzegovina;

Under paragraph (2), after the words “reconstruction and”, the word “sustainable” shall be added.

### **Article 2 (Entry into Force)**

This Amendment to the Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina shall enter into force on the next day following the day of its publication in the Official Gazette of BiH.
