AMENDMENTS TO THE RULES OF PROCEDURE OF THE HOUSE OF REPRESENTATIVES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA

NOTE: The Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina was published in the "Official Gazette of Bosnia and Herzegovina", 79/14.

Pursuant to Article IV/3b) and d) of the Constitution of Bosnia and Herzegovina and Article 186 of the Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina, at the 14th session, held on 21 December 2023, the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina adopted the following

AMENDMENTS TO THE RULES OF PROCEDURE OF THE HOUSE OF REPRESENATIVES OF THE PARLIAMENTARY ASSEMBLY OF BOSNIA AND HERZEGOVINA

Article 1

In the Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina", Nos. 79/14, 81/15, 97/15, 78/19 and 26/20, 53/22 and 59/23) in Article 43 (Standing Committees of the House), under sub-paragraph g), the words: "and kleptocracy", shall be deleted.

Article 2

Article 49a. (Committee for Combating Corruption and Kleptocracy) shall be amended to read:

"Article 49a. (Anti-Corruption Committee)

- (1) The Anti-Corruption Committee shall:
 - a) conduct parliamentary supervision aimed at detecting and preventing all forms of corruption, in accordance with the Law on Parliamentary Supervision;
 - b) monitor the activities of the Agency for Corruption Prevention and Coordination of the Anti-Corruption Activities and deliberate the issues of relevance for this Agency;
 - c) promote the activities in BiH Institutions aimed at combating corruption;
 - d) cooperate with judicial institutions and law enforcement agencies at the level of Bosnia and Herzegovina in the field of combating corruption;
 - e) deliberate the proposed laws and other regulations from the anti-corruption point of view;
 - f) deliberate the possibility of undertaking preparatory actions to enable the participation of Bosnia and Herzegovina's delegations in various international conventions, assemblies, meetings, etc., related to the implementation of international obligations of Bosnia and Herzegovina in the field of combating corruption, kleptocracy, conflict of interest, and other forms of corrupt practice;
 - g) deliberate the reports made by BiH institutions from the anti-corruption point of view;
 - h) cooperate with similar committees and parliamentary bodies of other countries and international organizations, including with foreign officials, concerning the anti-corruption issues;
 - i) carry out other activities prescribed by the Law on Parliamentary Supervision in the field of combating corruption;

- (2) The Committee shall also deliberate other matters or relevance in the field of combating corruption.
- (3) Notwithstanding the general provisions prescribed by Article 30 of these Rules of Procedure, the Committee Chairperson shall come from a political party that does not have a Minister or Deputy Minister appointed from among its membership to the Council of Ministers of Bosnia and Herzegovina. This provision shall be applicable at all times during the Committee's operation."

Article 3

These amendments to the Rules of Procedure of the House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina shall enter into force on the day following the date of publication of these Rules in the "Official Gazette of Bosnia and Herzegovina".
