LAW ON AMENDMENTS TO THE LAW ON HIGH JUDICIAL AND PROSECUTORIAL COUNCIL OF BOSNIA AND HERZEGOVINA

NOTE: The Law on High Judicial and Prosecutorial Council of Bosnia and Herzegovina was published in the “Official Gazette of Bosnia and Herzegovina”, 25/04.

Pursuant to Article IV. 4. a) of the Constitution of Bosnia and Herzegovina, at the 15th session of the House of Representatives, held on 30 January 2024, and at the 13th session of the House of Peoples, held on 31 January 2024, the Parliamentary Assembly adopted the following

LAW ON AMENDMENTS TO THE LAW ON HIGH JUDICIAL AND PROSECUTORIAL COUNCIL OF BOSNIA AND HERZEGOVINA

Article 1

In the Law on the High Judicial and Prosecutorial Council of Bosnia and Herzegovina (Official Gazette of BiH, 25/04, 93/05, 48/07, 15/08 and 63/23) in the title of Article 46 as well as throughout the text the word "duty" shall be replaced with the word "office".

Article 2

In Article 86, paragraph (8) the words: "assuming the office" shall be replaced with the words: "appointment to the office".

Article 3

In Article 86h, paragraph (2) the word "personal" shall be replaced with the word "secret".

Article 4

In the Law on Amendments to the Law on High Judicial and Prosecutorial Council of Bosnia and Herzegovina (Official Gazette of BiH, 63/23) in Article 27, at the end of the text, the punctuation mark "full stop" shall be replaced with the punctuation mark "comma" and the following words shall be added: "except for Articles 86 to 86e which shall be implemented from 23 March 2024".

After paragraph (1), paragraph (2) is added to read:

"(2) Provisions of Articles 11 and 12 of the Law on Amendments to the Law on High Judicial and Prosecutorial Council of Bosnia and Herzegovina (Official Gazette of BiH, 63/23) shall apply to disciplinary offences of judges and prosecutors committed from 23 December 2023, and the provisions of Articles 56 and 57 of the Law on High Judicial and Prosecutorial Council of Bosnia and Herzegovina (Official Gazette of BiH, 25/04, 93/05, 48/07 and 15/08) shall be applied to the offences committed before 23 December 2023".

Article 5

This Law shall enter into effect on the eighth day from the date of its publication in the Official Gazette of BiH.
