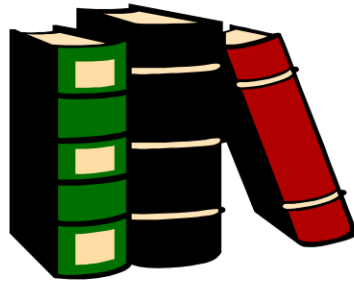

DECREE ON AMENDMENTS TO THE DECREE ON THE PROCEDURE OF VERIFICATION OF CLAIMS AND CASH PAYMENTS ARISING FROM FROZEN FOREIGN CURRENCY ACCOUNTS IN THE FEDERATION OF BOSNIA AND HERZEGOVINA

NOTE: Decree on the Procedure of Verification of Claims and Cash Payments Arising from Frozen Foreign Currency Accounts in the Federation of Bosnia and Herzegovina was published in the “Official Gazette of the Federation of Bosnia and Herzegovina”, 33/06.

On the basis of Article 18, paragraph (4) and Article 26 of the Law on Settlement of Liabilities for Frozen Foreign Currency Accounts (“Official Gazette of Bosnia and Herzegovina”, Nos. 28/06, 76/06, 72/07, 97/11 and 100/13), Article 5, paragraph (1) of the Law on Settlement of Liabilities for Frozen Foreign Currency Accounts („Official Gazette of the Federation of Bosnia and Herzegovina“, Nos. 62/09, 42/11, 91/13, 101/16, 57/20 and 19/25) the Government of the Federation of Bosnia and Herzegovina on the 205th urgent session held on May 22, 2025, hereby enacts the following

DECREE ON AMENDMENTS TO THE DECREE ON THE PROCEDURE OF VERIFICATION OF CLAIMS AND CASH PAYMENTS ARISING FROM FROZEN FOREIGN CURRENCY ACCOUNTS IN THE FEDERATION OF BOSNIA AND HERZEGOVINA

Article 1

In the Decree on the Procedure of Verification of Claims and Cash Payments Arising from Frozen Foreign Currency Accounts in the Federation of Bosnia and Herzegovina (“Official Gazette of Bosnia and Herzegovina”, No. 33/06, 66/06, 5/07, 65/07, 7/09, 4/10, 46/11, 32/12, 18/14, 41/15, 28/16, 42/17, 44/18, 67/20, 45/21 and 47/22), in Article 14, paragraph (1) shall be changed to read as follows:

“Deadline for submitting of request for verification of the frozen foreign currency accounts is starting from June 6, 2025 until October 31, 2025 and the Agency is obliged to finish the verification procedure until December 31, 2025”.

Article 2

This Decree shall enter into force on the day following its publication in the “Official Gazette of the Federation of Bosnia and Herzegovina”.
