ON AMENDMENTS TO THE LAW ON SETTLEMENT OF LIABILITIES FOR FROZEN FOREIGN CURRENCY ACCOUNTS OF THE FEDERATION OF BOSNIA AND HERZEGOVINA

Article 1

In the Law on Settlement of Liabilities for Frozen Foreign Currency Accounts of the Federation of Bosnia and Herzegovina ("Official Gazette of the FBiH", No. 62/09, 42/11, 91/13, 101/16 and 57/20), in Article 5, paragraph 1, the words: "31.12.2022" shall be replaced with the words; "31.12.2026".

Article 2

This Law shall enter into force on the next day from its publication in the "Official Gazette of Federation of Bosnia and Herzegovina".
